## **Course Description**

This course covers the fundamental concepts and application of descriptive statistics. It provides an introduction to probability and inferential statistics, including hypothesis testing with the normal and t distributions. It also covers elements of the R programming language, an open-source package for statistical data analysis that you can use on Computing Commons terminals or install for free on your own computer (macOS, Linux, or Windows).
